Joining FernÅindez in the ranks of the most powerful is Jane Fraser, the CEO of Citigroup Latin America. Citi operates in 23 countries in the region, which accounts for 15 percent of its parent company's global net profits. She is also the first woman to head the Latin American division of the firm.

Claudio Muruzab $\tilde{A}_i$ I, President of software giant SAP for Latin America and the Caribbean, is another new addition to the list. Muruzab $\tilde{A}_i$ I has more than 25 years of experience in the IT sector, having served as Vice President of NCR's Teradata for the region and also leading the successful evolution of NEORIS from the IT branch of CEMEX to being a worldwide consulting company.

The list also contains some of the region's best-known magnates who have shown their business prowess through good and bad times, such as Carlos Slim, Iris Fontbona, Luis Carlos Sarmiento Angulo, and Joseph Safra, to name a few.

However, each entry has been updated to include any new moves such as mergers or acquisitions each company may have made, as well as personal or other ventures each of the business leaders may have added to their repertoire.
